# ERAELIYA VILLAS & GARDENS TERMS AND CONDITIONS REGULAR BOOKINGS

#### 1. PAYMENT:

50% non-refundable deposit on the booking to guarantee, balance 30 days prior to arrival. During Peak Season 50% non-refundable deposit to guarantee, balance 60 days prior to arrival.

#### 2. CANCELLATION POLICY:

Eraeliya Villas & Gardens has a strict cancellation policy due to the exclusive nature of the hotel and its limited room availability.

All cancellations must be in writing and will be confirmed by our Sales/Reservation Manager.

# Cancellation charges are as follows:

- a. For cancellations more than 30 days before the arrival date a charge of 50% of the total booking amount will be levied.
- b. For cancellations 1–29 days before the arrival date and for no-shows, no refund will be made.
- c. During Peak and High Seasons, 30 days will be added to all cancellation periods.
- d. Any amendments that reduce the total booking amount will be treated as partial cancellation and may be subject to the cancellation fees stated above.

### 3. CHECK-IN / OUT TIMES:

Check-in - 14:00 / Check-out - 12 Noon.

Early Check-in and late Check-out are not guaranteed.

## 4. LIQUOR POLICY:
